VACANCY ROUND 2010-2011

The Institute has following branches:-

Exact number of vacant seats will be put up on website and college notice board on 21st September, 2010. Candidates desirous of admission may receive and submit the VACANCY ROUND REGISTRATION FORM in the college office from 13th September, 2010. The "FORM AND REGISTRATION FEE" is Rs.500/-. However, those candidates who have earlier registered under SINDHI QUOTA or INSTITUTE QUOTA have to compulsorily fill the VACANCY ROUND REGISTRATION FORM and have to pay Rs.100/- to confirm their interest in the Vacancy Round. Admission shall be made on the basis of CET score and minimum 50% marks in PCM in Qualifying HSC/XII Std. Examination. Eligible candidates are required to submit the form alongwith the Xerox copies of the documents. The last date to receive and submit the application for VACANCY ROUND is Tuesday 2nd September, 2010. Admissions strictly in order of CET merit shall commence in SEMINAR HALL, VIth Floor, WATUMULL INSTITUTE OF ELECTRONICS ENGINEERING & COMPUTER TECHNOLOGY Worli, Mumbai-400018 ON THURSDAY, 23rd September, 2010 AT 2:00 p.m. During admission, candidates shall submit original documents or retention certificate. Those candidates admitted shall submit the Demand Draft /Pay Order of Rs.74356/- @ drawn in favour of "PRINCIPAL, WATUMULL INSTITUTE, MUMBAI". Candidate, who does not submit the DD/Pay Order as above, shall pay a non-refundable fees of Rs.20,000/-(in cash). If the candidate fails to pay the balance fee on the next working day by 2.00p.m. in the college office, then the admission shall stand cancelled and also Rs.20, 000/- paid in cash by the candidate shall stand forfeited. @ This fees is interim and subject to change as per the decision of Shikshan Shulka Samiti.
